

# Welcome to the Kerikeri Cruising Club Marina

The marina was opened in Doves Bay in 1996 it has 193 berths; it was built for Club Members use. Berths range from 10m to 27m in length. Berths are rented on a daily basis with a midday to midday rental or on a discounted monthly basis, please enquire if this suits your needs. Doves Bay is a 15 minute drive into Kerikeri Township.

## Facilities

### Toilets, Shower and Laundry

These facilities are in the Marina Office/Amenities Block at the top of the marina carpark. There is a 24 hour shower/toilet open all year round beside the boatshed side of the building. Other showers and laundry are open during office hours. Showers, Washing Machine are \$2 coin each and the Dryer is \$4 per load (2x\$2 coins). Unless you have holding tanks we request that you use these toilets during your stay. The marina has a free holding tank pump out facility located on the fuel jetty.

### Power

All connections are via reynolds plugs. There is a \$2 per day connection fee. All leads connecting to power must have a current tag, any vessels which intends to connect but be left unattended must provide an Electronic Warrant of Fitness to the Office.

### Rubbish

The bins are at the top of C and B piers, for all rubbish including recycling. Oil recycling is over by the Marina Office.

### Water

The fresh water on the marina has not been treated. Water is in short supply as is all through rain water collection in tanks so please use sparingly. Water is for filling tanks. Washing down your vessel with fresh water can only take place in the winter months when no restrictions are in place as long as the hose being used has a trigger nozzle; free flowing hoses are not permitted. Please check with the office if these restrictions are currently operating or not. Only renters and licensees can fill their tanks from the marina others must fill from the fuel jetty and is coin operated at \$2 per 20Litres.

### Internet Access

Currently there is no WiFi in the marina.

### Carpark

All vehicles must observe speed and parking restrictions. If you intend to leave your vehicle here for any length of time we request that you park it us by the Clubhouse to reduce congestion down by the piers. All vehicles parked here at the owners risk.

### Fuel

Diesel is available on the Fuel Jetty at the top of Doves Bay. The Fuel Jetty only accepts Credit Cards. Decanting in the marina is not allowed.

### Dogs

Dogs must be kept on a leash we have kiwi in our bush. Please clean up any fouling by your animal and ensure proper disposal.

## Berth Rental Requirements

**Before Occupying a Berth the Marina Requires;**

### Personal and Vessel Details

In case of Emergency the Marina needs contact details.

**Payment in advance** (where practical)

### Insurance Documents

We Require Proof of at least third Party Insurance via an email or copy of the Certificate of Currency from your insurance company.

### Mediterranean Fanworm Declaration

Proof of last time boat was cleaned below the water and when last time boat was antifouled. Boats unable to produce this may not be allowed to enter the marina.

### Electrical Warrant of Fitness (EWOFF)

If intending to connect to marina power and leave vessel unattended the Marina must have an EWOFF on file or the boat will be disconnected.

### Liability and indemnity

The Club shall not be liable for personal injury to any person using the Marina or for any loss or damage to any boats within or about the Marina. The Club accepts no responsibility for the adequacy or otherwise of the Marina or the Berth or the facilities of the Marina or for the loss or damage to any property or the death or personal injury of any person incurred or suffered within the Marina however it occurs and whether or not attributable to the acts or defaults of the Club or its employees, agents, contractors, licensees, or otherwise.

## Marina Rental Rules

### The Occupier of the Berth shall not:


- Pollute or permit the pollution of the Marina or the waters of the Marina.
- Discharge or dispose of any sewage, garbage, oil, fuel or other material in the Marina except into containers provided by the Club.
- Carry out refueling other than at the fuel jetty.
- Use Marina firefighting equipment for any purpose other than the fighting of fires.
- Swim, dive or engage in underwater activities other than the cleaning of hulls.
- Consume alcohol except on private vessels.
- Moor, sail or manoeuvre about as to create a danger obstacle or inconvenience to Marina users.
- Cut or modify any mooring lines on the berth or use any metal fittings to secure the vessel.
- Store any dinghy or tender on the marina or in a berth.
- Allow their vessel whilst moored to extend beyond the dimensions of their rented berth.
- Engage in any significant maintenance work. The use of heavy machinery or grinders is not permitted. If planning anything other than minor repairs please discuss with Marina Manager.
- No commercial or charter boat may operate from this marina.

### The Occupier of the Berth shall ensure that:

- Whilst within the confines of the Marina, that the vessel, crafts and other property are fully insured. In absence of full insurance the Owner indemnifies the Club against all claims arising from the foregoing risks. Proof of Insurance must be provided to the Marina Office prior to occupying the berth.
- All dogs are led while on the Marina and in the surrounding native bush areas (Kiwi habitat).
- All halyards, lines, ropes, rigging and sheets are secured so that they do not create any noise.
- All mooring lines are adequate for the purpose of securing the vessel and comply with marina standards.
- All rental charges are paid in advance.
- Before connecting to the Marinas power Supply that the lead is tagged (current) and take precautions to prevent the lead from sagging or falling into the water.
- All handcarts are returned to the top of the gangway
- All existing lines belong to the berths owner, so as a courtesy please do not adjust permanent splice or use lines in such a way as to chafe.
- All contractors commissioned to work in the marina are fully insured and indemnify the Club against any loss, expense, legal liability arising from any issue caused by the contractor.
- That only one complete lead is used and is entirely uncoiled whilst in use.
- If the boat is to be left unattended whilst connected to power that a current EWOF is provided.
