## Notice of Champion Series

This is a closed event for Kerikeri Cruising Club members only.

### 1 Rules

- 1.1 The Kerikeri Cruising Club's divisional club champions for Divisions A and B will be decided upon a combined total of the General Handicap results from twenty (20) races from the two eligible series.
- 1.2 The eligible series for the 2014 – 2015 Club Champions are the Scottronic Technologies Wednesday night series and the Cater Marine Winter Series.
- 1.3 The Divisional Champion Series is to be run in conjunction with the relevant Notices of Race and associated Sailing Instructions for the two series in Clause 1.2. Refer to those documents for additional information.
- 1.4 All ten race results from both series will be accumulated to give a total of twenty (20) races for each of A and B Divisions in the Divisional Champion Series.
- 1.5 A total of six (6) worst performances will be discardable from a maximum of twenty (20) races sailed.
- 1.6 When fewer than 15 races have been completed, a boat's score will be the total of her race scores.
- 1.7 When 15 races have been completed, a boat's series score will be the total of her race scores excluding her worst score.
- 1.8 When 16 races have been completed, a boat's series score will be the total of her race scores excluding her worst 2 scores.
- 1.9 When 17 races have been completed, a boat's series score will be the total of her race scores excluding her worst 3e scores.
- 1.10 When 18 races have been completed, a boat's series score will be the total of her race scores excluding her worst 4 scores.
- 1.11 When 19 races have been completed, a boat's series score will be the total of her race scores excluding her worst 5 scores.
- 1.12 When 20 races have been completed, a boat's series score will be the total of her race scores excluding her worst 6 scores.

### 2 Eligibility and Entry

- 2.1 The series is open to all keel boats, multihulls, trailer yachts and sport boats, or other such craft that meet the entry requirements of the Scottronic Technologies Wednesday and the Cater Marine Winter series of races.
- 2.2 Every competing boat shall be registered with the Kerikeri Cruising Club and shall be owned or part owned by a member of the Kerikeri Cruising Club or the subject of a bona fide hire or charter agreement in accordance with Kerikeri Cruising Club Rules.
- 2.3 All boats shall be helmed at all times by a current financial member of the Kerikeri Cruising Club.

### 3 Prizes

- 3.1 The winners on General Handicap in each division in this series will receive their Divisional Championship trophy at the Club's annual prize giving.
- 3.2 The winner on PHRF in this series will be the PHRF Club Champion.
