Law North will provide written advice on this issue.

Whitianga no longer sells licenses so may not need a Statutory Supervisor or IFRS etc.

Berth license transfers process needs to be changed so KCC is not selling the licenses this may eliminate the need for a Statutory Supervisor.

Commodore & Marina Committee Chair will continue research into options.

Obtaining title of reclamation may also be a possibility.
