Storm Crowd Control – signage "Access to the Club is currently restricted to authorised persons for safety reasons".

Water leaks prior to Christmas due to heat on pipes Haul out busy
Sump pump for bore: P Pedersen to supply cable

Tree fall behind dinghy lockers, driveway

Storm prep done in accordance with plan but plan will be reviewed.

An initial post cyclone survey of the marina & boats was done & the work generated noted & begun.

E30 bolts tightened, stainless stell bolts tightened around the steel piles, timber walers being manufactured, wear strips being repaired & additional being installed as required, debris removed, E pier cleaned up, Dixon's approached for new pile guides, new pile guides will be fitted during next week's high tides, D pier T-head pile guide will be installed with ply packer to fit to existing pile

Mooring lines were a problem during the cyclone: 3 strand line seemed to fare better than braided 'dock lines'.

Options to improve the lines could include:

- a 'Dock Master' 1 x volunteer per pier to monitor lines
- Training for marina occupiers,
- Tonnage of vessel to be incorporated in the mooring line requirements

All marina committee to forward ideas to M MacDiarmid

In the meantime an email to all occupiers with current requirements & contact details for appropriate suppliers (Chains ropes & anchors etc) as well as other appropriate mooring line providers &/or splicers will be sent

Charging for ramp access in not an option due to the constraints of the Resource Consent. This has been explored as an option several times over the years. A donations box is installed. Contractor Insurance Premiums received relates to insurance premiums from 'small' contractors signing up to the Clubs Ship Repairers Insurance Policy Year to Date column helpful
