5 Maintenance

5.1 Pile Replacement

Quotes . Harbour Marine . unable to complete the work, not prepared to quote SeaNorth . quote not received

Plastic sleeve on timber piles, concrete piles. P Donahoe to have conversation about options with Total Marine to ensure we are following best practice.

Marina Committee recommends that KCC consults with Statutory Supervisor re the release of refurbishment funds for pile replacement & the level of due diligence required for the release of these funds. Committee agreed that as the KCC has directed that the funds should come from the refurbishment account there is no material benefit of splitting the project to stagger the expenditure.

5.2 Boat ramp project

It was resolved to recommend that the Kerikeri Cruising Club make application to the Statutory Supervisor to pay for the refurbishment of the boat ramp from the Refurbishment Account Stage II.

10% contribution from KCC towards the boat ramp refurbishment to be confirmed.

5.3 Mega Ds

P Donahoe suggests 7 x mega Ds as alternative to spring line Ds on the breakwater corner frames. Cost \$1,281 + GST.

It was resolved to approve the construction & installation of 'mega Ds' on breakwater spring points & A & B Ds as outlined by P Donahoe at a cost of \$1,281 + GST for the breakwater spring mega Ds.
