Safety remedial actions undertaken: White line around hairpin driveway corner repainted, trees thinned to allow better driveway visibility but more will be thinned to further improve safety, mesh installed around large drain hole.

Burnouts on the driveway – R Dempster to forward photo evidence, registration & contact details. Incident to be reported to the police.

Haul out incident: The Club's insurance details have been sought by a member hauled out in November 2022 for alleged boat damage.

Driveway trees being trimmed for storm/deluge preparation. The purpose of the trimming is to avoid falling trees bringing down the driveway cutting/clay banks. It is anticipated that trees will still be brought down in storm conditions but fallen trees are relatively quickly cleared. Landslides caused by fallen trees would pose a more substantial problem.
